I. ADMINISTRATION

A. Chair's Introductions & Announcements

B. Review of Antitrust & Meeting Guidelines

The secretary read the ARESCA guidelines which are applicable.

D. Review/Approve Agenda

The meeting agenda was accepted without changes.

E. Acceptance of Previous Minutes

The minutes from January 14 were accepted without changes.



II. <u>NEW BUSINESS</u>

- A. National Adoptions Subcommittee:
 - i. PINS submitted for 61400-3-1 and TS 61400-3-2.
 - 1. Will be published in Standards Action next Friday.
 - 2. ACTION: George will also circulate to TC88 TAG.
 - ii. Next steps
 - 1. ACTION: George will circulate ANSI steps to SCB members.
 - 2. Expect to submit BSR-8 (Public Comment) in mid-March.
 - 3. Need to confirm if/how we get text of IEC standards.
 - 4. Brian believes ANSI will request it from IEC.
 - 5. Kerry suggests we start designing an ARESCA cover page.
 - 6. Looked at UL for example of content.
 - 7. Discussed and decided not to include "IEC" in title/designation.
 - iii. No need to schedule next NAS meeting immediately, but Kyle will schedule one soon.
 - 1. Confirm submission of next 3 PINS (end of February)
 - a. -4 Gearboxes
 - b. -12-4 Site calibration
 - c. -50-3 Lidar
 - 2. Second priority will require national differences;
 - a. Need to recruit specific experts; we can submit PINS prior to starting discussions.
 - b. Recommendation from Kyle that -2 should be structured to satisfy both IEC and ACP requirements.
 - c. NAS will begin recommending groups of 5 to be submitted at once. (Next target end of March.)
 - 3. Discussed process for forming new subcommittees for each individual standard.
 - a. Kyle prefers to have SCB (rather than NAS) manage the creation of new subcommittees.
 - b. Discussed whether to submit many (or all) PINS preemptively to avoid any other SDO snatching them.
 - c. Kerry suggested to discuss strategy with ARESCA board next week.
 - iv. Still no feedback from ANSI on publication agreement. Bob following up with Tony Zertuche.
 - 1. ACTION: George to follow up with Leeane Lowry for



publication and royalty agreements.

- B. ACP responses to comments on OCRP-1
 - i. Lars reported that ACP will issue another ballot after changes responding to comments.
 - ii. May also revise scopes of OCRP-1 and -2.
- C. SCB Operating Procedures
 - i. **OPEN ACTION:** George to submit request for Public Notice in ANSI Standards Action.
 - ii. Reviewed and approved draft.
 - iii. **ACTION:** George will also post on ARESCA website.
- D. Other Topics of Interest
 - i. Coordination with ISO TC67 Lars provided brief update.
 - ii. BAC Kerry is a US member; voting in progress for 9 open positions; ARESCA may want to opine on candidates.
 - iii. Wind Standard Summit will be held on 29-30 March; 3 hours virtual each day.
