B. Review of Antitrust & Meeting Guidelines

The secretary read the ARESCA guidelines which are applicable:

The purpose of antitrust laws is to preserve economic competition in the marketplace by prohibiting, among other things, unreasonable restraints of trade. In ARESCA activities, it is important to recognize that participants often represent competitive interests. Antitrust laws require that all competition be open and unrestricted.

It is ARESCA's policy, and the policy of each of its committees and subcommittees, to conduct all business and activity openly and transparently, and in full compliance with international, federal and state antitrust and competition laws.

- A. National Adoptions Subcommittee:
 - i. Publications

 - 3. ANSI calculation of royalties for publication agreement

 - 1. 61400-12 open for comments until May 29
 - iii. PINS
 - 1. Submitted for 3 documents revoked from ACP
 - 2. Published 5-May; comment deadline 4-Jun
- B. ACP Adoption requests:
 - i. No response from ANSI or ACP closed
- C. TC114 adoptions:
 - i. Submitted 10 PINS for immediate adoption
 - ii. To be published today; comment deadline 11-Jun
- D. IEC project cancellations:
 - i. Anything older than 5 years will be cancelled at end of June.
 - ii. Major impact on -15-2; will have to initiate new NP and reappoint project team members.
 - iii. Kyle suggested there should be some exceptions for existing projects.

 - i. **ACTION:** George & Bob will provide estimate of how much is required to cover cost of publishing.
 - ii. Need some more input from ANSI
 - iii. May want to initiate some new standards outside of IEC system

 - ii. Interest in conformity certificates for projects (need to develop new)
 - iii. Bob involved in IEC ad hoc group; will report first progress at USNC meetings next week.
